## BRIEFING NOTE FOR THE ASSISTANT DEPUTY MINISTER

#### FOR INFORMATION ONLY

SUBJECT: **Greyhound Bus Route Termination** 

#### SUMMARY:

- Greyhound announced that it will discontinue bus service in western Canada, with the exception of a Vancouver/Seattle route, by October 31, 2018.
- Ceasing intercity bus operations will have substantial impacts on communities, particularly Indigenous and rural populations, which rely on Greyhound as a main source of transportation.
- It is generally expected that private companies will be unlikely to fill the gaps left by Greyhound's departure.
- Although the federal government has not recently been active in the economic regulation of intercity bus transportation, the Prime Minister has asked Transport Minister Marc Garneau to find solutions to Greyhound's withdrawal.
- Alberta Premier Rachel Notley and Brian Mason, Alberta Minister of Transportation, characterize the Greyhound closure as a pressing issue of national importance, requiring a Canada-wide solution.

#### **BACKGROUND:**

- Greyhound is an intercity bus carrier company owned by British Transportation company FirstGroup, with headquarters in Texas.
- Greyhound cites decreasing ridership as the main reason for the decision, along with increased car ownership, and competition from other passenger transportation options. Greyhound ridership has decreased by 41 per cent for the company since 2010.
- The closure is expected to impact two million consumers and 400 locations across Canada, with 107 of those areas being in Alberta. In addition, 415 job losses (155 in Alberta) are also expected.
- Private sector operators indicate that they will be able to meet package delivery demand previously taken care of by Greyhound's freight service.
- On July 12, 2018, western Canada provincial transportation ministers met to discuss Greyhound's departure. According to the Government of British Columbia, the transportation ministers agreed to write a letter to Minister Garneau to advocate for Canadian transportation interests.

- service needs. In particular, concerns exist for Indigenous women and girls as being strongly negatively impacted by Greyhound's transportation discontinuation.
- No federal programs currently exist that would provide operational subsidies for private
  intercity bus carriers. Transport Canada is not actively involved in supporting service provision
  across Canada, as economic regulation of inter-provincial bus carriers has been delegated to the
  provinces under the federal Motor Vehicle Transport Act.
- Individual jurisdictions are free to subsidize transportation routes and carriers, if desired.

- Under Alberta's Rural Transportation Pilot Program, \$1.4 million has been funded to improve public transportation between mid-sized urban centres (Camrose, Grande Prairie, and Spirit River) with surrounding communities.
- In terms of transportation alternatives in Alberta, Red Arrow (including eBus) provides intercity bus services to Edmonton, Red Deer, Calgary, Fort McMurray, and Lethbridge, along with connector services to Cold Lake, Bonnyville, and Smoky Lake.
  - o In response to Greyhound's announcement, Red Arrow has stated that the company has no immediate plans to expand, but will continue to evaluate any business opportunities.
  - Red Arrow mentioned that community-based shuttle programs and government-issued competitive request for proposal (RFP) processes may provide the best value to tax payers and rural communities.
- Potential policy solutions to improve access to rural intercity bus transportation can include: coordinating connections between transportation providers; differing regulations, including operating monopolies; providing direct operating subsidies to private companies; subsidizing government-owned bus routes; and nationalizing intercity bus industries. Some considerations for these options include cost, amount of provided service, and long-term system sustainability.

- b. Providing business services by delivering a range of business counselling and information services to SMEs and Social Enterprises
- e. Providing access to capital to assist existing SMEs and Social Enterprises or to help entrepreneurs to create new SMEs and Social Enterprises.
- d. Supporting community-based projects and special initiatives by collaborating with other partners in the public sector and civil society to implement strategic community projects or deliver special initiatives targeted to communities. These projects would vary considerably from one community to another and could include a wide range of local initiatives in areas such as tourism, entrepreneurship, economic opportunities for specific client groups such as women, youth, Aboriginal people and members of official language minorities, or projects which respond to specific challenges facing a community such as downturns in important industries.

#### Issue:

 Greyhound announced on July 9, 2018 that it will discontinue passenger bus and freight services in western Canada, with the exception of a Vancouver/Seattle route, by October 31, 2018.

PM Trudeau has asked TC Minister Garneau to find a solution to Greyhound's decision.

## **About Greyhound:**

- Greyhound Canada is the largest provider of intercity bus transportation in Canada, with over 1100 routes.
- Greyhound is owned by British transportation company FirstGroup, with headquarters in Texas.
- The company cites that their reason for the discontinued services are due to a 41% decline in ridership since 2010, increased competition from subsidized national and inter-regional passenger transportation services, growth of low-cost airlines, regulatory constraints and the growth of car ownership. Greyhound notes that ridesharing companies, along with illegal operators have also cut into their business.
- Greyhound has raised their issues with both levels of government for years. They have advocated for a community funding model that allows any private carrier to bid on essential rural services.

## Manitoba Impacts:

- According to the company, Greyhound services 114 communities in Manitoba and sees 92,000 passengers annually.
- It runs five busses on five routes daily out of Winnipeg, two heading north, two West, and one eastward bound.
- It was reported that 64 jobs in Manitoba will be lost when the routes are discontinued. A total of 415 jobs will be lost nationally.
- Manitoba Infrastructure Minister Ron Schuler says they will not be providing any subsidies to Greyhound.
- The previous NDP government subsidized Greyhound for a few years, but stopped the subsidies in 2016.
  The government at the time promised a study of the industry just before the 2016 election to address the issue of lack of bus service in the province (it appears this study never came to fruition).

## Rural and First Nations communities:

- Assembly of Manitoba Chief Arlen Dumas says the shutdown will have a negative impact on First Nations, especially on northern communities that rely on the service for medical appointments.
- Chief Dumas has called on the provincial and federal governments to help fill the gap Greyhound's departure will leave
- <u>Dumas has indicated that he has spoken to PMO</u>, and was told that there are ongoing efforts to find a workable solution.

## Small Business:

- Small business that use Greyhound's cheaper freight services will be impacted by the discontinued freight services
- Companies such as <u>Fourway Motors</u>, <u>located in MacGregor</u>, <u>Manitoba</u> was interviewed saying the higher freight costs will likely be passed onto customers.

## Greyhound bus terminal in Winnipeg:

- It is unknown if the nearly decade old Greyhound bus terminal located at the Winnipeg James Armstrong Richardson International Airport will be abandoned or repurposed, although the latter is the most likely scenario. The terminal was opened in August 2009.
- The terminal provides passenger and freight services.

#### Motor Coach Industries:

- Motor Coach Industries (MCI) is a supplier of Greyhound busses along with Prevost.
- In 2013, Greyhound placed its largest order in more than 20 years for 220 new busses from MCI (130 buses model D4505) and Prevost (90 busses X3-45). Orders were to be completed by 2014.
- It is unknown if the reduction of services will negatively impact MCI.

#### Alternative Transportation and Freight Providers:

- In the wake of the announcement, several transportation companies have indicated that they are able to fill the void that Greyhound will leave behind.
- Anecdotally, a few Manitoba First Nations currently operate their own shuttle services to Winnipeg.
- An Ontario company, <u>Kasper Transportation</u>, <u>CEO Kasper Wabinski</u> says it will begin running more busses to and from Winnipeg, including one to Thompson. The company will likely be using smaller busses that seat 25-35 passengers.
- Ride sharing companies could potentially service rural and northern communities. However providing freight services or taking passengers to go across the country will likely not be possible or affordable.
- Package delivery firms such as FedEx and Purolator have said they are able to handle the delivery demand.
- Handi-Van's operating in communities such as Teulon and Gimli run services to Winnipeg for medical
  appointments. The service is funded by the municipality, provincial government and the regional health
  authority.

## WD Analysis:

- This issue is not new and has surfaced many years ago. In fact, subsidy programs were in place to assist Greyhound, but their situation has not improved.
- In 2009, a Task force made up of Deputy Ministers responsible for Transportation and Highway Safety came together to address the declining intercity bus services. The task force was chaired by Manitoba Infrastructure and Transportation. The task force report was released in 2010. It indicated that a loss of intercity bus service would impact Manitoba provincial government services and programs. The study noted that family visits and reunification efforts will be impacted negatively, witnesses in judicial cases may have difficulty attending court proceedings, and there will be a disruption in health services. The report recommended a modest subsidy program to sustain lower volume routes and several changes to the National Safety Code and Transportation Act.
- With many companies indicating that they can provide similar services as Greyhound, it seems that the market will self-correct and third party providers could potentially fill the void that Greyhound leaves behind.

David McNabb (DG Surface Transportation at TC - I'll call him "TC David") reached out to me re: the Greyhound service issue. An officials meeting (which you have been invited to) involving PCO, Finance, TC, AANDC to discuss options has been set up for August 17.

TC David and I talked about what they are trying to do:

- Gather info and analysis to provide a view into the extent of the impact of Greyhound ceasing almost all of its operations in Western Canada at the end of October; and
- Develop options/discuss ideas re: what the federal government can do.

Attached is an e-mail that provides a good overview of TCs thinking and what they are looking for from the federal family and some good background on the issue (interprovincial bus transportation is legally a provincial domain, but provinces are pressuring the federal government 20(1)

We discussed this issue at Policy Committee earlier in the week,

Back to the call with TC David - I indicated to him that there isn't much that we can likely do as of November 1 to solve the bus service issue and that we do not have data on ridership, communities served by Greyhound, impacts (economic or social) of Greyhound ceasing operations, etc. Indicated a couple of things though. First, we do have a flexible program authority, but, not a lot of expertise in the transportation industry. We also have the ability to help convene if that is useful as well. Anyway, not knowing where Dylan stands on this issue and given our limitations on this file, I did not want to get adventurous on positioning WD as a department that could strongly contribute on this.
