I am writing to you on behalf of Manitoba Agriculture and Resource Development to share our most recent evaluation and concerns regarding grain drying costs for producers in Manitoba.

As you are aware, Manitoba producers experienced extraordinary rain and snowfall in September and October 2019. This forced the harvest of crops with higher than average moisture, resulting in much higher fuel costs due to increased demand for post-harvest drying.

The total estimated fuel drying costs for the 2019 harvest range between \$22 and \$38 million. The additional carbon tax estimates range between \$2 and \$3 million. These estimates assume 70% propane and 30% natural gas usage and a breakdown of fuel costs and carbon tax by crops is shown below.

In addition to drying grains, farmers use natural gas and/or propane for heating potato storages, greenhouse, and livestock production facilities. Taking all on-farm energy uses into account, the 2019 federal carbon tax adds about \$5 million to the energy bills of Manitoba producers, which will increase to \$7.5 million with the \$30 per tonne tax that was implemented on April 1, 2020. This is an extra financial burden to our producers.

There is an immediate need to alleviate this unnecessary financial pressure to our producers in an effort to ensure the ongoing stability of the Agriculture sector. I look forward to your response.
