ISSUE: Environmental Assessment and Licensing Status of the Sio Silica Sand Extraction Development


BACKGROUND: Sio Silica submitted an Environment Act proposal in July 2021 for a silica sand extraction development (class 2 development). They propose to extract silica sand from the Winnipeg Sandstone aquifer in the Rural Municipality of Springfield. Under The Act, there are three classes of developments. Class 1 developments (such as manufacturing and food processing plants) and class 2 developments (such as sewage treatment plants and mining developments) are licensed by the Director of Environmental Approvals Branch and appealable to the Minister of Environment and Climate. Class 3 developments (major hydro developments and flood control) are licensed by the Minister of Environment and Climate and appealable to Cabinet.

The Act includes a provision that if a Clean Environment Commission (CEC) public hearing is held on a class 1 or 2 development, the Minister may, after giving written notice to the Director and proponent, make the licensing decision (issue or refusal).

The proposal underwent the environmental assessment review process with input by technical experts across government, a public review, section 35 consultations with Indigenous communities and a technical review and public hearing by the CEC. All this input informs the licensing decision and conditions within the licence.

Given the highly technical nature of the project and public concerns raised, the Minister requested the CEC to undertake a technical review and public hearing. The CEC submitted their report to the Minister on June 22, 2023. The report summarizes the assessment process, the technical review, and the public hearing and included eight recommendations (see **Appendix A**).

The Environment Act outlines the following process for notification of adoption of the CEC recommendations: if any CEC recommendations are not included in the licence or refused, the Director shall provide written reasons for the decision to the proponent, the Minister, the commission and the public registry at the time of notifying the proponent of the licensing decision.


On June 22, 2023, the CEC provided a report with recommendations on the public hearings for the proposed Vivian Sand Extraction Project to the Minister of Conservation and Climate. The report was published on the CEC website and on the Conservation and Climate online public registry.

The CEC report provided eight specific recommendations for consideration in the ongoing environmental assessment and licensing process for the proposed sand extraction project.



ISSUE: Environmental Assessment and Licensing Status of the Sio Silica Sand Extraction Development

BACKGROUND:

Sio Silica, a private company based in Alberta, submitted an Environment Act proposal in July 2021 for a silica sand extraction development. They propose to extract silica sand using novel technology from the Winnipeg Sandstone aquifer in the Rural Municipality of Springfield.

The area contains a large deposit of high purity silica sand suitable for ultrahigh clarity glass (solar panels, fibre optics, semiconductors, etc.).

Sio Silica is seeking an Environment Act license for a 4 year initial project, which includes phase one (initial well drilling, exploration and testing/monitoring) and phase two (extraction and further monitoring) with approximately 1,200 wells in clusters of 5 over 1,564 ac. This is an initial project prior a longer term 20 year full scale extraction plan for the area. Only the first 4 years has been proposed for licensing consideration.

The proposal involves extraction of silica sand from an aquifer that provides drinking water supply for the region. There has been significant public concerns raised with the proposed extraction regarding impacts with drinking water safety.


The Clean Environment Commission (CEC) was asked to review the Sio Silica proposal with public input and provide recommendation to the Minister. The CEC conducted public hearings in February 2023 and a report was provided in June 2023.

The CEC raised cautions with the Sio Silica proposal and provided a number of recommendations.

In addition to the CEC review and public hearings, the proposal underwent the environmental assessment review process with input by technical experts across government and section 35 consultations with Indigenous communities.


ANALYSIS:

Over the past few months, a technical advisory team representing multiple departments have reviewed the CEC report and recommendations in consideration of a licensing decision.
